### GLAT(ADMISSION & SCHOLARSHIP TEST 2023)

Candidate seeking admission to Geeta Institute of Law College is required to give GLAT (Admission & Scholarship Test 2023) for admission to BA.LL.B. (Hons.)/BBA.LL.B. (Hons.) 5 years program. GLAT 2023 shall be conducted on Saturday, 20th May 2023 through "Online/Offline Mode".

### ELIGIBILITY

#### BA. LL.B. (Hons.) 5 Years/ BBA. LL.B. (Hons.) 5 Years Programme

- For GEN/OBC Category, Candidates must have minimum 45% aggregate marks in 10+2 examination or equivalent (students appearing in qualifying examination 2023 can apply).
- For SC/ST Category, Candidates must have minimum 42.75% aggregate marks in 10+2 examination or equivalent (students appearing in qualifying examination 2023 can apply).
- Candidates shall be below Twenty One (21) years of age as on 31st July.
- Admission will be done on merit basis i.e. their performance in GLAT (Admission & Scholarship Test 2023) conducted by Geeta Institute of Law and thereafter Personal Interview.

#### LL.B. (3 years) Programme

- For GEN/OBC Category, Candidates must have minimum 45% aggregate marks in Bachelor's degree in any subject (students appearing in qualifying examination 2023 can apply).
- For SC/ST Category, Candidates must have minimum 42.75% aggregate marks in Bachelor's degree in any subject (students appearing in qualifying examination 2023 can apply).
- Admission will be done on the basis of their Personal Interview.

#### LL.M. (2 years) Programme

- For GEN/OBC Category, Candidates must have minimum 55% aggregate marks in qualifying examination (i.e. LL.B./Five-Years Integrated LL.B. (Hons.)/ any other equivalent exam) (students appearing in qualifying examination 2023 can apply).
- For SC/ST Category, Candidates must have minimum passing marks in qualifying examination (i.e. LL.B./Five-Years Integrated LL.B. (Hons.)/ any other equivalent exam)(students appearing in qualifying examination 2023 can apply).
- Admission will be done on the basis of their Personal Interview.
